# Special Meeting Minutes July 26, 2022 5:00 p.m.

### 1. Call to Order

Council Member Block called the meeting to order at 5:07 p.m.

7. Motion to adopt Tentative Millage Rate and set First Budget Hearing date and Time.

Millage Rate 4.6000

Hearing Date: Monday, September 12, 2022 at 5:00 PM

Mayor Deno mentioned that our Millage Rate last year was 4.9000 and that the Village's rollback rate is 4.5704. Mayor Deno stated that with a Millage Rate of 4.6000, our tax rate will decrease by 6%.

A motion to adopt Tentative Millage Rate of 4.6000 made by Council Member Fernandez was seconded by Council Member Conover. The motion passed 3-0.

A motion to set the First Budget Hearing meeting on September 12, 2022 at 5:00 PM made by Council Member Fernandez was seconded by Council Member Conover. The motion passed 3-0.

Chief Hernandez stated to the Council that there are three police officer applicants: Angel Lopez, Osvaldo Leyva, and Ruben Yero. Chief Hernandez mentioned that Mr. Lopez and Mr. Yero will be part-time officers, and Mr. Leyva will be a reserve officer. Mayor Deno mentioned that he is in support of giving these officers a chance here at the Village.

A motion to approve the three Police Applicants made by Council Member Fernandez was seconded by Council Member Conover. The motion passed 3-0.

#### 10. Good & Welfare

Mayor Deno stated that he and Council Member Fernandez had an idea to have three Meet & Greets for business owners and the new annexation area. Mayor Deno mentioned that one Meet & Greet can be at Village Hall, and the other two Meet & Greets can be at Aloft Hotels, Homewood Suites, or at Beat Culture Brewery in the annexed area. Member Conover agreed that this is great idea, especially having it done within the annexation area.
