1. Call to Order

6. Citizens Comments

Jason Neil from Waste Management is offering the Village of Virginia Gardens the following terms;

- A service rate of \$30.50 per home.
- Rate Adjustments will change from 2 per year (CPI capped at 5% each January and disposal increase each October with no cap) to one per year, each January, which would be CPI capped 8%.
- Services will remain the same: twice a week at the curve and quarterly bulk collection.

7. Discussion regarding the proposed Police Contract submitted for 2023-2026

The following changes have been made throughout the Proposed Police Contract. These changes have been reviewed and approved by the Council and, in some cases, involve the removal or modification of specific sections and provisions;

On Page 10, ARTICLE 6 Section 6.1, the Last paragraph is to be reviewed by Attorney Cuadra.

On Page 16, Article 12, Section 12.5, and Section 12.6 have been approved by the Council.

On Page 20, ARTICLE 16, Section 16.2. Council approved changes.

ON Page 23 ARTICLE 19 Section 19.2 Council Approved 5% for Step 1 to Step 6 from the proposed 8% and removed Step 7 and Step 8.

On Page 23, Article 19 Section 19.3, the Council approved a 5 % salary increase based upon the sole discretion of Council members and the Mayor's recommendation.

On Page 23, Article 19 Section 19.4 was approved by the Council.

On Page 24, Article 20, Section 20.1 and Section 20.2 has been removed.

On Page 25, Article 21, Section 21.1 and Section 21.2 have been approved by the Council.

On Page 26, Article 22 Section 22.2, Changes are approved for Article 26 and Article 27.

On Page 27, Article 21-23 Section 23.1, the Council has approved changes.

On Page 28, Article 24, Section 24.1, 24.2, and 24.3 have been approved by the Council.

On Page 31, Article 26 Section 26.3, the Council approved 420 hours instead of 480 as noted.

On Page 32, Article 27, Section 27.1, and Section 27.4, Officer's Birthday was removed, and the Council approved Juneteenth and 3 Personal Leave Days.
