Special Council Meeting Minutes August 28, 2023 5:30 p.m.

1. Call to Order

Council President Jorge Arce called the meeting to order at 5:35 p.m.

2. Invocation

6. Citizens Comments

Discussion regarding the proposed Police Contract submitted for 2023-2026 Domingo Montoute Howard and VP, Mrs. Elena Shaffer from PLEA were in attendance representing VG officers.

The following changes have been made throughout the Proposed Police Contract. These changes have been reviewed and approved by the Council and, in some cases, involve the removal or modification of specific sections and provisions;

ON Page 23, Article 19 Section 19.2, the Council Approved 6% for Step 1 to Step 6 from the proposed 8% and removed Step 7 and Step 8.

On Page 23, Article 19 Section 19.3, Based on Longevity status. The Council approved a salary increase of no less than 3.5 % in perpetuity with a maximum of 6 % based upon the sole discretion of Council members and the Mayor's recommendation.

On Page 25, Article 21, Section 21.1 and Section 21.2 have been changed from 3% to 5 %. The Council has approved changes.

On Page 27, Article 21-23 Section 23.1, the Council approved four (4) hours.

On Page 31, Article 26 Section 26.3, the Council approved 420 hours instead of 480 as noted.

On Page 47, Addendum I, All officers with Longevity status will receive a 6% salary from October 1, 2023, through September 30—2024, contract year.

Officers requested Shift differential compensation. The Council disapproved.

A motion to approve changes to the agreement between law enforcement and the Village of Virginia Gardens was made by Council Member Conover and was seconded by Council Member Block .The motion passed 5-0.
