The following Variance has been requested by FORNARIS LLC 5721 NW 36 Street, with respect to Chapter 16 section 7.1.4 of the Village of Virginia Gardens code so as to allow for an increased in sign allowable area

- 7.1.4(A) The gross surface area off all signs on a lot with only one business of for each licensed business shall not exceed 80 square feet in area.
- * Sign on the South Wall: 44.6 Sq ft.- Would exceed allowed area by 9.2 sq.ft. *Pylon Sign:83.3 Sq. ft.- Would exceed allowed area by an additional 83 sq.ft.
- * NOTE: A sign on the East wall (81.3 Sq. ft.) is being processed for approval under the permitting process. Variances requested herein contemplate approval of the Eastern wall sign.

Total Sign area = 212 SF

Exceeds total allowable area (212-80 SF) by 132 SF
