Variance Request

THE FOLLOWING VARIANCES HAVE BEEN REQUESTED BY 36TH ST STORAGE LLC WITH RESPECT TO CHAPTER 16 SECTIONS 3.3.2(d), 6.6, 6.23, & 6.6.2 OF THE VILLAGE OF VIRGINIA GARDENS CODE SO AS TO ALLOW FOR THE DEVELOPMENT OF A SEVEN STORY HOTEL.

- Section 3.3.2(d): To allow Hotel in Restricted Commercial District via "Special exemption" since it is not included in uses allowed.
- Section 6.6: To permit a F.A.R. of 1.21 where Section 6.6 Table 6.6.1 Lot dimensions, Setbacks and Bulk Requirements of the Village's Code for Restricted Commercial specifies an F.A.R. of 1.0 maximum.
- Section 6.6: Table 6.2.1 which restricts the height to three (3) stories and forty-five (45) feet. The Owner is seeking a variance to permit a construction of seven (7) stories with a height of seventy four (74) feet to the roof line and a four (4) foot parapet, for an overall height of seventy –eight (78) feet for the building perimeter walls, but elevator overrun eighty-three (83) feet and architectural feature facing 36th Street with a maximum height of eighty –nine (89) feet.
- Section 6.2.3(6) Table 6.2.1 which requires a Front Setback (36 Street) of thirty-five (35) Feet. The Owner is seeking a variance to permit a Front Setback of twenty- four feet seven inches (24'7) and twenty-one feet seven inches (21'7).
